

Notification of Exemption and Repayment

We are sending it to those who borrowed the following funds.

Redemption (returning borrowed money) has started from January 2023. If you have not paid yet, please use the payment form that has already been mailed to you.

We will continue to accept those who did not apply for exemption from reimbursement due to tax exemption of residence tax (per capita rate / income rate) in FY2021 or FY2022. Please apply as soon as possible.

Those who will be subject to resident tax (per capita rate/income rate) in FY2021 or FY2022, however, those who are exempt from resident tax (per capita rate/income rate) for FY2023 for the borrower and householder, the amount after the month one year after the redemption start month (the month when you return the borrowed money) will be exempted. Please refer to the enclosed booklet ③"Procedures for redemption exemption application, redemption, and redemption postponement".







² Tax Exemption Certificate

What is a Tax Exemption Certificate that shows that a taxpayer is exempt from both per capita and per income taxes of resident tax?

This is a document issued by the municipal office of your residence (**) that certifies the taxable amount of the individual.

If you borrowed the above funds,

Please obtain a certificate for either the "fiscal year 2021 or 2022 or 2023" in which you are exempt from taxation on "both per capita and per income tax".

- *Certificates for the fiscal year 2021 can be obtained at the municipal office of the city, ward, town or village where you reside as of January 1, 2021.
- *Certificates for the fiscal year 2022 can be obtained at the municipal office of the city, ward, town or village where you reside as of January 1, 2022.
- *Certificates for the fiscal year 2023 can be obtained at the municipal office of the city, ward, town or village where you reside as of January 1, 2023.
- •The months for which exemptions are available depend on the certificate for the fiscal year being submitted. See pages 1-3.
- **XEX** Please note that the "Notice of Reduction (Cancellation) of Citizen's and Prefectural Tax Amount" is not a certificate of tax exemption.
- •Depending on the municipality, an "income taxation certificate" or "municipal/prefectural inhabitant tax income/taxation certificate" with the taxable amount of "0" may be issued instead of a tax exemption certificate.

If the equalization and income tax rates are listed as 0 yen, the applicant is exempt from taxation.

Frequently Asked Questions

- Q1. Where and how do I get a tax exemption certificate?
- Q2. I would like to obtain a tax exemption certificate, but I have not filed a tax return, year-end adjustment, or resident tax return.
- Q3. I do not know if the residence tax is exempt.

Aichi Prefectural Social Welfare Council and the respective municipal councils of social welfare are unable to answer questions regarding taxes, such as those listed on the left.

Please contact the tax department of your local municipal office.

·If you have not filed an income tax return or made a year-end adjustment, you may not be issued a certificate of tax exemption unless you file an inhabitant tax return. For information on how to file resident tax returns, please contact the tax department of your local municipal office.

- •If you are currently reimbursed by bank transfer or payment slip from January 2023, but have difficulty reimbursing your loan, you may apply for a "deferment of reimbursement" to postpone your reimbursement for up to 12 months.

• (For those who have paid by payment slip) Information on procedures for account transfer

- •If you register your account for reimbursement, the debit will be made on the 27th of each month.
- •For those who cannot go to the Japan Post Bank to make a transfer when the bank is open, a direct debit is convenient.
- •The registered account will be the common reimbursement transfer account for all loans.







If you are eligible for deferment of reimbursement, please send the enclosed ⑤ "Application for Deferment of Reimbursement of Small Emergency Special Loan for Livelihood and Welfare Fund Loan Program" along with the necessary documents to the Aichi Social Welfare Council Special Loan Reimbursement Administration Center by return envelope.

[Documents required for application]

- 1 Application for deferral of redemption $\overset{.}{\times}$ If there is more than one loan, a single application form is required to defer all loans eliqible for deferment.
- ② Proof documents, etc. required for application for the following eligibility requirements (Any one of these is fine.)

Eligibility Requirements	Required documents for application [Any one of these is fine.]
1 Those affected by earthquake, fire, etc.	Certificate of disaster, etc.
2 Persons under medical treatment	Medical certificate, medical condition certificate, etc.
3 Unemployed or unemployed	Certificate of resignation, release form, etc.
4 Those who have received a deferment of other loans, such as scholarships or business loans (excluding mortgages)	Documentation confirming that the applicant has received a deferment of reimbursement of other loans
5 When, as a result of consultation with a consultation support organization for self-reliance, the said organization submits an opinion that it is appropriate to postpone the redemption due to the borrower's living conditions. (Please refer to the list of consultation offices of self-reliance consultation support organizations on the next page.)	Investigation Opinion by Self- Reliance Counseling and Support Organization
6 Those who are recognized by the chairperson of the Prefectural Council of Social Welfare as having extreme difficulty in reimbursement due to the same reasons as those listed above. Attention

In order to properly provide the necessary support for rebuilding their lives, please receive support from the Self-Reliance Counseling and Support Organization under the Livelihood Support System for the Needy as much as possible.

The grace period (postponement of repayment) will be granted for up to 12 months from the month in which the application for grace period and certification documents arrive at the Redemption Office of the Aichi Social Welfare Council Special Loan.

We will contact you if there are any incomplete documents, etc.

A payment slip may be sent after submitting a deferment application, but reimbursement is not required during the redemption period.

In addition, if deposits are made by direct debit in the month in which the grace period begins, the deposit amount will be refunded in the following month.


Consultation Support Services for Self-Reliance
